Club Equipment Plan:

Billet Fee \$500/month (max)

Equipment will be the property of the player as long as the fee is paid in full

ALL CLUB FEES ARE SUBJECT TO HST

All Players who are traded and/or released, or who suffer a season ending injury, are entitled to a refund of any participation fee based on the number of Club games remaining in the regular season schedule.

In the event the Player quits and/or leaves the Club anytime during the season, from the first regular season game and or beyond, there will be no League and or Club Refund.

Any violation of the League and/or Club Policies could result in suspension, loss of playing privileges and/or dismissal from Club, with or without any Refund at the discretion of the NOJHL Commissioner

THIS AGREEMENT MADE THIS _____ DAY OF _____

AMONG: **Soo Thunderbirds Jr A Hockey Club**

(Hereinafter called the 'Club) OF THE FIRST PART

(Hereinafter called the 'Player')

AND _____
(Hereinafter called the 'Parents')

WHEREAS the Club is a registered Junior A Hockey Club playing in the Northern Ontario Junior Hockey League and operating out of the city/town of Sault Ste Marie in the Province Of Ontario

Purpose

- The purpose of this agreement is to provide an outline and guide lines for all Players that play for the Soo Thunderbirds Jr A Hockey Club as to what is allowed and expected with the participation within the NOJHL and the Soo Thunderbirds Jr A Hockey Club.

- This agreement will be enforceable by the Commissioner of the NOJHL and all sanctions and discipline rulings are not appealable to the NOHA, OHF or Hockey Canada.

This agreement is set out in the following section:

NOJHL Player's League Fee: \$1,136.00 +HST =\$1,283.68

Showcase Fee: \$350.00 + HST =\$395.50

The player will pay this amount \$1,679.18 to the Club who will then transfer this amount to the League Office.

Equipment deal:

1. Skaters Fee: \$1,200.00 + HST
 - a) 6 Sticks, 2 pairs of gloves, shell, helmet, equipment bag, track suit, and clothing

The equipment mention above will be the property of the player as long as the fee has been paid in full.

Player's Club Fee: \$5,000.00 + HST(max) (This amount does not include the NOJHL Player's League Fee and the Equipment deal)

Player's Club Fees include:

1. 54 games (average 2-3 per week)
2. Transportation to and from all games by highway coach
3. Road trip meals and hotel lodging, 2 to a room
4. Complex gym membership and access to all complex amenities
5. Discounted rates for team physiotherapist and message therapist
6. Up to 5 practices per week where schedule permits
7. Dedicated team dressing room

8. Gatorade, tape, game and practice jerseys, socks, medical supplies and other necessary supplies.

Club Refund Policy

1. As per attached League refund policy
2. All Players who are traded and or released, or who suffer a season ending injury, are entitled to a refund of any participation fee based on the number of Club games remaining in the regular season schedule.
3. In the event the Player quits and/or leaves the Club anytime during the season, from the first regular season game and/or beyond, there will be no League and or Club Refund.
4. Any violation of the League and/or Club Policies could result in suspension, loss of playing privileges and/or dismissal from Club, with or without any Refund at the discretion of the NOJHL Commissioner.

Billet Fees: \$500.00 / month(max)

- 1) All fees are paid to the billet family at the first of the month by post dated cheque.
- 2) Player must abide by team billet policies

Community Service:

- 1) Player will attend all team functions and community services as required by coaching staff and management.

CLUB code of conduct:

- 1) Player will read and sign separate team code of conduct agreement

Payment Plans:

Option A: Full payment of the NOJHL Player's League Fee, Showcase Fee and Player's Club Fee upon signing both agreements

Option B: Payment arrangements may be discussed on a case-by-case basis, UP TO THE CLUB TO ADD OR MODIFY THE INFO **BUT**

For each Player, the NOJHL Player's League Fee has to be paid in full before playing their first game (if the money is paid by payment the first payment has to be equal or greater than the NOJHL League Fee)

Player Discipline:

The parties confirm, acknowledge and agree that any violation of the terms of this Agreement will constitute a breach of the fundamental principles of the Northern Ontario Junior A Hockey League and/or the Club. A violation of any of the provisions of this Agreement, may result in the immediate suspension of the Player from participating in Club and/or Northern Ontario Junior A Hockey League activities, including, but not limited to, practices and/or games, for a period of not greater than twelve (12) months as determined by the NOJHL Commissioner and /or the Club Management or if constituted, the committee or individual(s) empowered by the Commissioner and the Club to oversee such matters. All decisions are final and may not be appealed to the NOHA, the OHF or Hockey Canada.

By signing this agreement, all parties fully understand the meaning of this agreement and have indicated so by signing it of their own free will.
